450MWp (HPP)

브라질의 재생에너지 발전용량은 84%로 세계 평균 38%보다 높다. 막대한 투자로 인해 브라질 에너지 매트릭스에서 태양에너지 비중은 6.9%, 풍력에너지 비중은 10.9%에 이르렀다.
